Dear Shareholder,

Billington Holdings Plc – Notice of Annual General Meeting

The Annual General Meeting (“**AGM**”) of Billington Holdings Plc (the “**Company**”) will be held at Steel House, Barnsley Road, Wombwell, Barnsley, South Yorkshire, S73 8DS on 1 June 2021 at 2pm.

I am pleased to send you the notice of this year’s AGM. Our preference would have been to welcome shareholders in person to our 2021 Annual General Meeting, particularly given the restraints we faced throughout 2020 and into this year as a result of COVID-19.

However, at present and in accordance with the “roadmap for lifting lockdown” announced by the Prime Minister on 22 February 2021 there will continue to be restrictions and limitations in relation to public meetings at the time the 2021 AGM is scheduled to take place. This will once again, therefore significantly limit the ability of shareholders to attend the AGM.

The Board recognises that the AGM is a valuable forum that provides shareholders with an opportunity to raise questions and comments to the Board. However, the health and safety of our employees, shareholders and wider stakeholders are of paramount importance and the Board fully supports the measures being taken by the Government. On this basis, and assuming the continuation of restrictions on public meetings, **shareholders, will not be able to attend the Company’s 2021 AGM in person.**

In order to comply with our articles of association and relevant legal requirements, this years AGM will be convened with the minimum necessary quorum of two shareholders. This will be facilitated by the Company.

We nevertheless recognise the importance of shareholders being able to cast their votes in respect of the business of the AGM as early as possible. This can be done by completing and signing the attached proxy form which can be submitted either by post or electronically to dkemplay@billington-holdings.plc.uk .

Shareholders are encouraged to appoint the “Chairman of the meeting” as their proxy to vote on their behalf as we will be unable to admit any other proxy to the AGM. Proxy forms must be returned by the deadlines as detailed on the enclosed proxy form.

Due to the exceptional circumstances we once again find ourselves in this year we will be holding a video link question and answer session following the conclusion of the business of the AGM. Should you wish to take part could you please provide an appropriate email address to the Company Secretary via dkemplay@billington-holdings.plc.uk by no later than the close of business on Thursday, 27 May 2021. We will then arrange to send you a link to this question and answer session which will be conducted via Microsoft Teams, you will need to have downloaded this to a suitable device in order to participate.

This year there are 7 resolutions to be considered and voted on by shareholders. Resolutions 1 to 6 (inclusive) are proposed as ordinary resolutions. This means that for each of those resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolution 7 is proposed as a special resolution. This means that for this special resolution to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

Shareholders should continue to monitor the Company's website and announcements for any updates regarding the AGM.

I set out below a brief explanation of the resolutions.

- **RESOLUTION 1 – Receipt of the 2020 Annual report and financial statements**

The Directors are required by company law to present the financial statements, the Directors' report and the auditors' report on the financial statements to the meeting.

- **RESOLUTIONS 2 & 3 – Re-election of Directors**

Under article 101 of the Company's articles of association, at the annual general meeting in every year one-third of the Directors (or the nearest number to one-third) shall retire from office. The Directors to retire in each year are those who have been longest in office since their last election. All retiring Directors are eligible for re-election and at this year's annual general meeting the board proposes the re-election of M Smith and T M Taylor as a directors of the Company.

- **RESOLUTION 4 – Declaration of a final dividend**

The Directors recommend a final dividend of 4.25 pence per share for the year ended 31 December 2020.

- **RESOLUTION 5 – Re-appointment and remuneration of auditors**

The Company is required at each general meeting at which financial statements are laid to appoint auditors who will remain in office until the next general meeting at which financial statements are laid before the Company. Grant Thornton UK LLP have expressed their willingness to continue in office for a further year. The shareholders are also asked to authorise the board to fix the auditors' remuneration.

- **RESOLUTION 6 – General authority to allot shares**

This resolution asks shareholders to renew the Directors' authority to allot relevant securities as defined in Section 551 of the Companies Act 2006. The authority, if approved, will expire on the fifth anniversary of the date of the resolution. The authority would allow the Directors to allot relevant securities of the Company up to a nominal value of £431,144.

- **RESOLUTION 7 – Disapplication of pre-emption rights**

If the Directors wish to allot unissued shares (and other equity securities) for cash, the Companies Act 2006 requires that these shares are offered first to shareholders in proportion to their existing holdings. This is known as shareholders' pre-emption rights. There may be occasions, however, when in order to act in the best interests of the Company, the Directors need the flexibility to finance business opportunities as they arise without offering securities on a pre-emptive basis. Therefore, this resolution asks shareholders to renew the Directors' authority to allot shares (or other equity securities) for cash up to a nominal value of £64,672 without offering them to other shareholders on a pre-emptive basis. This resolution is intended to be valid until the earlier of the next annual general meeting or the date which is 15 months from the date of this resolution.

Action to be taken

Shareholders are invited to complete and sign the enclosed form of proxy in accordance with the instructions thereon and return it to the Company Secretary as soon as possible and, in any event, so as to be received no later than 48 hours before the holding of the AGM.

Recommendation

The Directors consider that all of the resolutions to be proposed at the AGM are in the best interests of the Company and its shareholders as a whole and unanimously recommend that shareholders vote in favour of all the resolutions, as the Directors intend to do in respect of their own beneficial shareholdings.

Finally, I would like to take this opportunity to thank all of our shareholders for their support and understanding in these continuing unprecedented times.



THAT, the Director of the Company be given the general power under Section 570 of the Companies Act 2006 to allot equity securities (as defined in Section 560 of the Companies Act 2006) for cash, pursuant of the authority conferred by resolution 6 set out in the notice of the annual general meeting of the Company dated 3 May 2018, as if Section 561(1) of the Companies Act 2006 did not apply to any such allotment, provided that this power shall be limited to:-

- (a) the allotment of equity securities in connection with an offer by way of a rights issue or open offer.
 - (i) to the holders of ordinary shares (including for the avoidance of doubt the "A" ordinary shares) in proportion (as nearly as may be practicable) to their respective holdings; and
 - (ii) to holders of other equity securities as required by the rights of those securities or as the Directors otherwise consider necessary.

but subject to such exclusions or other arrangements as the Directors may deem necessary or expedient in relation to treasury shares, fractional entitlements, record dates, legal or practical problems in or under the laws of any territory or the requirements of any regulatory body or stock exchange; and

- (b) the allotment (otherwise pursuant to paragraph (a) above) of equity securities having an aggregate nominal amount of up to £64,672.

The power granted by this resolution will expire on the earlier of the conclusion of the annual general meeting of the Company next following the date upon which this resolution becomes effective or the date fifteen months following the date upon which this resolution becomes effective (unless renewed, varied or revoked by the Company prior to or on such date) save that the Company may, before such expiry, make offers or agreements which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of any such offer or agreement notwithstanding the power conferred by this resolution has expired.

This resolution revokes and replaces all unexercised powers previously granted to the Directors to allot equity securities as if Section 561(1) of the Companies Act 2006 did not apply but without prejudice to any allotment of equity securities already made or agreed to be made pursuant to such authorities.
